Re: REQUEST FOR TRADING HALT

In accordance with Listing Rule 17.1, Morning Star Holdings (Australia) Limited (the **Company**) requests that a trading halt be granted by the ASX prior to the General Meeting of the Company to be held at 11.00am EST on the 18 July 2008 at Level 15, 25 Bligh Street, Sydney NSW 2000.

At the General Meeting shareholders will consider a number of resolutions including:

- the proposed change of activities constituted by the Company's acquisition of Alumicor; and
- the consolidation of the Company's share capital on a 1:2 basis.

If shareholders do not approve the resolutions, the trading halt is expected to be lifted when the Company confirms that it will not change its activities.

In accordance with ASX's requirements for compliance with Chapter 11 of the Listing Rules, if shareholders approve the resolutions the Company will be suspended from official quotation for the period immediately following the meeting of shareholders and until the time the Company has complied with Chapters 1 and 2 of the Listing Rules.
