

### **QMETCO LIMITED MODERN SLAVERY STATEMENT**

QMetco Limited and its operating subsidiary (QMetco) are committed to taking the issue of modern slavery seriously, including identifying, assessing and mitigating modern slavery risks in our operations and supply chains, by being compliant with all modern slavery legislation and by using our commercial leverage to reduce and contribute towards the elimination of modern slavery.

Forms of modern slavery include (but are not limited to) people trafficking, slavery, forced marriage/ labour, child labour, debt bondage, servitude, and deceptive recruiting for labour or services are a violation of human rights, against the law and are completely at odds with the Company's Core Values:

- No Games,
- Be Resourceful,
- Care & Respect,
- Deliver Together,
- Challenge the Norm.

QMetco expects our employees, contractors, suppliers and business partners to:

- comply with all applicable laws, awards and agreements relating to the employment of their workers and modern slavery;
- take steps to identify, address and mitigate modern slavery existing in their operations and supply chains; and
- be transparent about modern slavery risks or occurrences, including by answering relevant questions and providing relevant information when reasonably requested.

#### **MODERN SLAVERY REPORT 2020**

### QMetco structure, operations and supply chains

QMetco is a privately owned company incorporated under the Corporations Act 2001.

There is one operating asset, being the Foxleigh Coal mine in central Queensland, with a small head office in Brisbane.

The mine is operated by, a subsidiary, Foxleigh Management Pty Ltd (FoxMan) on behalf of an unincorporated Joint Venture (JV) comprising:

- Foxleigh Coal Pty Ltd (FoxCoal) (70%) subsidiary and reporting entity
- POSCO Australia Pty Ltd (20%)
- Nippon Steel Australia Pty Ltd (10%)

Other non-operating assets are in Canada and the United States.

QMetco supply chain relates to procurement of good and services to operate a coal mine with the following general expenditure categories:

- Mining equipment
- Explosives
- Diesel fuel
- Mining consumables
- Labour and other contract services
- Maintenance services
- Port and Rail access
- Water and Electricity supply
- Finance, insurance, and other professional services

# Risks of modern slavery in operations and supply chains

QMetco operations are carried out entirely within Australia and all employees are engaged on terms and conditions which comply with Australian laws and are free to join and be represented by unions.

The majority of procurement items are sourced from suppliers which are Australian based or have operations within Australia and operate under Australian laws. For the most part, these organisations have sophisticated supply chain policies and procedures in place.

However, some organisations tend to have long supply chains in multiple countries, and we acknowledge that modern slavery risks can be present further down these supply chains. We expect increasing visibility into the actions taken by these suppliers as they move to report in accordance with the requirements of the Modern Slavery Act 2018 (Cwth).

QMetco supports local businesses and contractors within regional communities for minor procurement of goods and services, which operate under Australian laws and may not have extensive supply chains procedures.

## Actions taken by QMetco during the reporting period.

QMetco is committed to operating ethically and legally, partnering with suppliers that are aligned to the values of the company and adhere to the terms of the company's commercial agreements.

The following actions were actions undertaken by QMetco during the reporting period:

- The QMetco Board approved a Modern Slavery Statement and 2020 report that outlines the company's commitment to addressing modern slavery, expectations of suppliers, employees and business partners and procedures for reporting instances of modern slavery.
- All Directors and Senior Leaders, including key procurement personnel undertook online Modern Slavery awareness and education.
- QMetco and FoxMan Risk Committees have added Modern Slavery as a standing agenda item.
- 4. A project has commenced to review and update QMetco's procurement contract templates and purchase order terms to require assurance and other undertakings from suppliers in relation to modern slavery and labour practices. This will include representations that suppliers of goods and services will be engaged in accordance with all relevant legal requirements and awards, and that neither the supplier nor its immediate suppliers have engaged in illegal slavery-like offences. This project is targeted to be completed by 31 December 2021.

### **Measuring Effectiveness**

QMetco will measure effectiveness through:

- Presence of the modern slavery risk as a standing item on Risk Committee agendas
- Monitoring key and large suppliers' implementation of Modern Slavery Statements.
- Continue promotion of a greater level of awareness within our business of the nature and risks of modern slavery.

## Consultation with subsidiaries and JV partners

While the Foxleigh JV is not a reporting entity, QMetco, through FoxMan, has discussed with JV partners and there is a commitment to share statements and actions to promote awareness and learning. Modern Slavery has been added as a standing agenda item for JV Committee meetings.
