EPBC 2010-5421 (30 Sep-21) - ANNUAL COMPLIANCE REPORT CY21

During CY21 an EPBC variation application was processed, and approval was granted on 30 Sep-21. The changes involved:

- An extension of the validity period to 31 Dec-50
- An increase in the disturbance areas of Protected Matters to reflect the mine plan
- A modernisation of some of the Approval conditions

These changes and outcomes from the CY21 wet season Offset survey triggered a review of the Offset Management Plan (OMP) – approved 12 Dec-16 and in effect for CY21 reporting period.

Herbicide affected and thin aspect ratio offset areas were removed, new offset areas were identified, and ecological studies undertaken. Various drafts were discussed with DAWE resulting in a finalised submission on 7 Feb-22 for approval. On 15 Feb-22 the delegate of the Minister of the Environment approved an updated Biodiversity Offset Management Plan (BOMP) which will form the basis for management and reporting going forward.

The mine operates under a Groundwater Monitoring and Management Plan (GMMP) approved 18 Apr-16

Two independent reviews were undertaken to investigate anomalous readings with both concluding that there were no compliance issues identified. A maintenance review of the Vibrating Wire Piezometers is being scoped and a review of the groundwater model is currently underway.

Appendix 1 provides an update against each of the EPBC conditions.
